<u>Call to Order:</u> The Emmetsburg Public Library Board of Trustees monthly meeting was called to order by Acting President Jan Stillman at 5:04 p.m. on Tuesday, June 19, 2022, in the Conference Room 14 of the Emmetsburg Public Library. Trustees present were Stillman, Joel Hoyman, JaDee Gloede, Joe Schany, Marilyn Carlstrom, Sue Brown, and Joe Veltri. Trustees Jacob Neff, and Vice President Kathy Merrill were absent. Library Director Nathan Clark was also present.

<u>Agenda Approval:</u> The agenda prepared by Library Director Clark was posted and distributed in advance of the meeting. Trustee Brown moved to approve the agenda, which was seconded by Trustee Gloede. The motion carried, 7-0.

<u>Minutes Approval</u>: The minutes of the May meeting were prepared by Library Director Clark in advance of the meeting. Trustee Gloede made a motion to approve the minutes of the May 2022 meeting. The motion was seconded by Trustee Schany and carried, 7-0.

<u>Bill Approval:</u> The expenses for the month of May 2022 were read by Library Director Clark. Trustee Veltri moved to approve the expenses of May 2022, which was seconded by Trustee Carlstrom and carried, 7-0.

<u>Public Comment:</u> No members of the public were on hand for the public forum.

Correspondence: No correspondence was presented this month.

Board Committees: Finance & Budget Committee: The committee did not meet since the last Board meeting and has no report.

Recruitment & Orientation: The committee did not meet since the last Board meeting and has no report.

Standards & Accreditation: The committee did not meet since the last Board meeting and has no report. Library Director Clark said that he would like to schedule a meeting of this committee to do the annual review of standards.

<u>Library Director's Report:</u> Library Director Clark described another month full of programs with something on the calendar nearly every day during June and July.

Clark also mentioned that the staff were pleased with the number of individuals signed up for the Summer reading program. As the library has not previously held a teen or adult program, he was delighted to see such enthusiasm for joining these.

Clark shared that the library had booked Duffy Hudson, the same actor who played Edgar Allan Poe at the library last Fall, to play Harry Houdini in a one-man show Thursday, July 21, 2022 at 6:30 p.m.

Clark told the trustees that he was currently enrolled in a class: "Prune Your Collection." The course was through the University of Wisconsin, Madison and was about weeding (library collections).

Lastly Clark solicited ideas for what the library could offer RAGBRAI riders during their stay.

Unfinished Business:

The policy up for review, the Board of Trustees Bylaws, was given its first reading with amendments from the previous meeting. A section was added to address the requirements put forth in *In Service to Iowa*. Trustee Veltri made a motion to accept the first reading of the amended bylaws. The motion was seconded by Trustee Brown and carried, 7-0.

The matter of pricing for new tables and chairs was brought up. The trustees agreed that discussion of new furnishings could not go forward until the matter of the leaky roof was addressed. They directed Library Director Clark to draft another letter to the college administration inquiring about a timeline for its repair.

New Business:.

The trustees watched the last 20 minute segment of the training video from the *Foundations of Public Libraries* series: "The Library Team & Support Organization" with Bonnie McKewon.

An election of officers was held with the following results: Kathy Merrill, president; Jacob Neff: Vice President; Library Director: Secretary.

<u>Adjourn:</u> Acting President Stillman adjourned the meeting at 6:07 p.m.. The next meeting of the Board of Trustees is scheduled for Tuesday, July 19, 2022 at the Emmetsburg Public Library.
