<u>Call to Order:</u> The Emmetsburg Public Library Board of Trustees monthly meeting was called to order by President Kathy Merrill at 5:01 p.m. on Tuesday, September 20, 2022, in the Conference Room 14 of the Emmetsburg Public Library. Trustees present were Merrill, Sue Brown, Joel Hoyman, Marilyn Carlstrom, Jan Stillman, Joe Veltri, and Vice President Jacob Neff. Trustees Joe Schany and JaDee Gloede were absent. Library Director Nathan Clark was also present.

<u>Agenda Approval:</u> The agenda prepared by Library Director Clark was posted and distributed in advance of the meeting. Trustee Brown moved to approve the agenda, which was seconded by Trustee Stillman. The motion carried, 7-0.

<u>Minutes Approval:</u> The minutes of the August meeting were prepared by Library Director Clark in advance of the meeting. Trustee Stillman made a motion to approve the minutes of the August 2022 meeting. The motion was seconded by Trustee Carlstrom and carried, 7-0.

<u>Bill Approval:</u> The expenses for the month of August 2022 were read by Library Director Clark. Trustee Veltri moved to approve the expenses of August 2022, which was seconded by Trustee Hoyman and carried, 7-0.

Public Comment: No members of the public were on hand for the public forum.

Correspondence: There was no correspondence to discuss this month.

Board Committees:

Finance& Budget Committee: The first meeting concerning the FY2024 budget request was held for the hour before the regularly scheduled September 20, 2022 meeting in Room 14. The committee was able to do a run-through of all the line items.

Recruitment & Orientation: The committee did not meet since the last Board meeting and has no report.

Standards & Accreditation: The has now met three times in the past two months and has completely run through the standards laid out in the latest edition of *In Service to Iowa*. A

<u>Library Director's Report:</u> Library Director Clark described meetings he had attended recently and mentioned that the day before he was at a meeting where Jamie Neff from the Palo Alto County Iowa State University Extension Office spoke and talked about the visioning project that occurred in Emmetsburg. Clark said that he thought it would be helpful to have Neff present at our next board meeting about the visioning activities that had already been done in this community as the board works on its next long-range plan. The board told Clark to put her on the agenda for the next meeting.

Clark mentioned that while the Monday-Thursday Afterschool Homework Help program is not seeing large numbers, the first few weeks of the Pokémon Club on Friday afternoons are promising.

Clark said that he thinks the numbers have been helped by the school visits to the Middle School, where he and Anna Veltri spoke with all the Middle Schools students over eight periods. He added that Anna spoke to the lion's share of these classes.

Clark shared that tomorrow is a two-hour early out day, and that there are programs planned for both older and younger children.

Finally, Clark told the trustees that the library would again be hosting a live performer with Jillann Gabrielle returning to perform her one-woman play, "Oh, Jackie O.!

Unfinished Business:

Discussion of the Tables/Chairs pricing was tabled until resolution of the leaking roof.

The policy up for review, the Youth Services Director Job Description, was given its second reading. A few wording changes and relocations were made at the last meeting: an item 11 was added under Essential Responsibilities: "Implement and remain current with rules, regulations and instructions." Two uses of doing things "well" were changed to "effectively." Item 5 under Physical Demands, "Work [effectively] as a team member," was moved under: "To do this kind of work, you must be able to:". Trustee Stillman made a motion to accept the second reading of the policy as amended. The motion was seconded by Trustee Neff and carried, 7-0.

New Business:

Library Director Clark went with President Merrill to the Algona Public Library, which has been completely remodeled on the inside, to view their new children's shelving. The shelving is a bit different from conventional library shelving. It offers more built-in space for front-facing display of books and offers books in a record store bin-type shelving, which is also front-facing as opposed to conventional, spine-out shelving. The advantages of the new shelving are that the books sit down lower for younger people and are more enticing being front facing. The disadvantages would be a decreased ability to scan shelves for items to retrieve them and their reduced capacity per like-sized ranges, which means the collection size would have to be reduced.

The trustees watched a 20-minute segment of the training video from the *Foundations of Public Libraries* series: "Ten Habits of Highly Effective Boards" with Patrick Callahan

<u>Adjourn:</u> President Merrill asked for a motion to adjourn the meeting at 6:16 p.m. Trustee Brown moved to adjourn, and Trustee Veltri seconded the motion. The meeting was adjourned. The next meeting of the Board of Trustees is scheduled for Tuesday, October 18, 2022 at the Emmetsburg Public Library.
