## **Emmetsburg Public Library Board of Trustees Regular Monthly Meeting**

**Emmetsburg Public Library** 

5:00 p.m., Tuesday, April 18, 2023

<u>Call to Order:</u> The Emmetsburg Public Library Board of Trustees monthly meeting was called to order by President Kathy Merrill at 5:01 p.m. on Tuesday, April 18, 2023, in the Conference Room 14 of the Emmetsburg Public Library. Trustees present were Merrill, Sue Brown, Joel Hoyman, Vice President Jacob Neff, Marilyn Carlstrom, Joe Veltri, and Joe Schany. Trustee Jan Stillman joined the meeting by telephone. Trustee Amy Stewart was absent. Library Director Nathan Clark was also present.

<u>Agenda Approval:</u> The agenda prepared by Library Director Clark was posted and distributed in advance of the meeting. Trustee Brown moved to approve the agenda, which was seconded by Trustee Schany. The motion carried, 8-0.

<u>Minutes Approval:</u> The minutes of the March meeting were prepared by Library Director Clark in advance of the meeting. Trustee Stillman made a motion to approve the minutes of the March 2023 meeting. The motion was seconded by Trustee Neff and carried, 8-0.

<u>Bill Approval</u>: The expenses for the month of March 2023 were read by Library Director Clark. Trustee Veltri moved to approve the expenses of March 2023, which was seconded by Vice President Carlstrom and carried, 8-0.

<u>Public Comment:</u> No members of the public were on hand for the public forum.

**Correspondence:** No correspondence was presented at the meeting.

**Board Committees:** Finance & Budget Committee: The committee has not met since the last Board meeting and has no report.

Recruitment & Orientation: The committee has not met since the last Board meeting and has no report.

Standards & Accreditation: The committee has not met since the last Board meeting and has no report.

<u>Library Director's Report:</u> Library Director Clark shared spreadsheets showing the library's income, expenditures, and trust fund balances in the current fiscal year through the end of February 2023. Clark also shared statistics showing the library's circulation by type of item for March 2023

Clark told the trustees about the preliminary plans for the Summer Reading Program for Adults, Teens, Tweens, and Children. He said this year's theme is "Find Your Voice!"

Clark also told the trustees about a new program that Anna had seen other libraries doing: "100 Books before You Graduate." In the program, students who finish eighth grade are engaged to read 100 books before they graduate high school. Incentives are provided for milestones along the way like 25, 50 and 75 books read. Upon their graduation year, if the students have read 100 books, they are entered in a drawing held each year to win a big prize, like an iPad. Clark added that he was very interested in

offering the program at Emmetsburg, for while there is an abundance of initiatives out there to get very young children to read, he feels this one stands somewhat alone in incentivizing high schoolers to read. Trustee Hoyman made a motion to adopt a "100 Books before You Graduate" program for high schoolers and to purchase incentives appropriate to the program. The motion was seconded by Trustee Veltri and carried, 8-0.

Clark told the trustees that the library's trivia night at The Shores on Saturday, April 15<sup>th</sup> saw lower attendance than expected, but was still a good time for those involved.

Clark reminded the trustees that the library will be hosting Jillann Gabrielle again in the evening of Thursday, April 20th, this time performing a double role as Joan Crawford/Bette Davis in her one-woman musical show.

Clark told the trustees that the library would be hosting a ceramics painting program on Saturday, April 22<sup>nd</sup>. Attendees will receive a piece to paint that is already cleaned, fired, and ready to paint and take home. All paints and supplies will be provided.

### **Unfinished Business:**

The policy up for review, the Safe Child Policy, was given its second reading. In the second paragraph, in the first sentence, the language had been changed to read: "...the staff may attempt to contact," rather than will attempt. The final sentence of the policy was also changed to state that "...the Emmetsburg Police Department may be called..." Vice President Neff made a motion to accept the second reading of the policy as amended. The motion was seconded by Trustee Schany and carried, 8-0.

Trustee Hoyman left at 5:51 p.m.

<u>New Business:</u> The policy up for review, the Tornado and Thunderstorm Policy, was given its first reading. No changes were suggested. Trustee Stillman made a motion to accept the first reading of the Tornado and Thunderstorm Policy. Vice President Neff seconded the motion. The motion carried, 7-0.

The policy up for review, the Bulletin Board Policy was given its first reading. No changes were suggested. Trustee Schany moved to accept the first reading of the Bulletin Boards Policy, which was seconded by Trustee Brown and carried, 7-0.

For the Board Education Module, the board watched the first installment of "Boardroom 2022: Policy Watch: Policy Topics "Lost and Found." The recording was paused at the 18:52 mark.

### Agenda Items for Next Meeting:

<u>Adjourn:</u> President Merrill asked for a motion to adjourn the meeting, which was made by Trustee Veltri, seconded by Vice President Neff, and carried, 7-0. The meeting was adjourned at 6:16 p.m. The next meeting of the Board of Trustees is scheduled for Tuesday, May 16, 2023 at 5:00 p.m. in Room 14 Conference Room of the Emmetsburg Public Library.
