<u>Call to Order:</u> The Emmetsburg Public Library Board of Trustees monthly meeting was called to order by President Kathy Merrill at 5:00 p.m. on Tuesday, October 17, 2023, in the Conference Room 14 of the Emmetsburg Public Library. Trustees present were: Sue Brown, Joe Veltri, Joel Hoyman, and Marilyn Carlstrom. President Merrill joined by telephone. Vice President Jacob Neff and trustee Joe Schany were absent. Library Director Nathan Clark was also present.

<u>Agenda Approval:</u> The agenda prepared by Library Director Clark was posted and distributed in advance of the meeting. Trustee Brown moved to approve the agenda, which was seconded by Trustee Hoyman. The motion carried, 5-0.

<u>Minutes Approval:</u> The minutes of the September 2023 meeting were provided for the trustees. Trustee Veltri moved to approve the minutes of the September 2023 meeting. The motion was seconded by Trustee Carlstrom, and carried,5-0.

<u>Bill Approval:</u> The expenses for the month of September 2023 were read by Library Director Clark. Trustee Veltri moved to approve the expenses of September 2023, which was seconded by Trustee Brown and carried, 5-0.

Public Comment: No members of the public were on hand for the public forum.

<u>Correspondence</u>: A memo from Megan Jones at City Hall was presented concerning the the 2023 PACGDC Grants. With the city's internal deadlines, any mini grant application the library submits must be turned in directly after the next board meeting. Discussion of the grant is on the agenda under New Business.

Board Committees: Finance & Budget Committee: The committee has not met since the last Board meeting and has no report. A meeting of the Finance & Budget Committee was scheduled for an hour before the next regular monthly meeting.

Recruitment & Orientation: The committee has not met since the last Board meeting and has no report. It was agreed that Library Director Clark would follow up with Joe Schany and Amy Stewart about their status on the board.

Standards & Accreditation: The committee has not met since the last Board meeting and has no report.

Library Director's Report:

Library Director Clark talked about the month of programming planned for November in celebration of International Games Month. He also shared the Reading Dragons program with them, which is a collaboration with the college library where trading cards are given out to readers as prizes. The program will run throughout the period outside of the Summer Reading Program. He said that Kat Rogers, the college's newest employee was instrumental in bringing the program about.

Clark reminded the trustees that there would be a return visit of Jillann Gabrielle performing her newest one-woman show, *Lucy!* on Tuesday, November 7th. He encouraged the trustees to attend and to help spread the word.

<u>Unfinished Business:</u> The policy up for review, the Personnel Hours Policy was given its first reading. It had been tabled at the last meeting. No changes were suggested. Trustee Hoyman made a motion to accept the first reading of the Personnel Hours Policy. The motion was seconded by Trustee Veltri and carried, 5-0.

The policy up for review, the Confidentiality Policy was given its second reading. No changes were made at the last meeting, and no changes were suggested. Trustee Hoyman made a motion to accept the second reading of the Confidentiality Policy. The motion was seconded by Trustee Brown and carried, 5-0.

New Business:

Three grant opportunities were discussed: the Early Childhood North Central Iowa Literacy Grants, the Palo Alto County Gaming Development Corporation Grants for 2023, and the Kossuth Cluster Community Partnership for Protecting Children. Library Director Clark laid out his plans for these requests. He wanted to apply for various items to enhance programs and collections for children aged 0-5 for the ECNCI Grant, as that was the purview of the grant. He wanted to request a package of video game consoles, video games, board games, and role playing game items to enhance the library's gaming programs. Clark said that the DCAT grant would be the ideal opportunity to do something with the afterschool food programming that was included in the Long Range Plan.

Library Director Clark and President Merrill gave a review of their meeting with the ILCC President and Vice President. They stated that they felt listened to, and that ILCC was willing to devote a grant request to attempting to fix the roof. However, this puts the soonest the issue is resolved at the Summer of 2024.

For the Board Education Module, the board watched the next in the Library Law Series, "Serving Families, Part two, in its entirety.

<u>Adjourn:</u> President Merrill asked for a motion to adjourn the meeting, which was made by Trustee Veltri, seconded by Trustee Carlstrom, and carried, 5-0. The meeting was adjourned at 6:05 p.m. The next meeting of the Board of Trustees is scheduled for Tuesday, November 21, 2023 at 5:00 p.m. in Room 14 Conference Room of the Emmetsburg Public Library.
